Joint Statement in response to the announcement of Changes to Victims Support proceeding

1 July 2020

Dear Commissioner,

We, the undersigned, are deeply disappointed by the announcement that Victims Services will proceed with changes to the Victims Support Scheme from 1 July 2020.

We remain of the view that the changes will significantly impede victim-survivors' access to the support to which they are entitled and need. This will particularly impact on those who have experienced domestic violence, sexual assault, child abuse and child sexual abuse.

You have acknowledged the difficulties Victims Services have in collecting evidence on behalf of victim-survivors in a timely manner. Shifting the burden from Victims Services onto victim-survivors to collect their own evidence and imposing a 12-month timeframe from the date of lodging an application in which to collect evidence are fundamental changes to the system. This is contrary to the cornerstone of the scheme which has been its accessibility.

We do not have confidence in a 6 month review.

We continue to hold the view these changes should not proceed and a comprehensive victim-survivor led review commence immediately.

If the changes proceed in the face of continued strong opposition by victim-survivors and their advocates, it would be our hope and expectation that the comprehensive statutory review be the proper place to review the changes. We call on the Department of Communities and Justice to release baseline data relating to the areas of impact that have been raised.
